Thanks to all who were involved in the event setup as well as to those who came out and helped get 2011 off to a flying start.



AMA, FAA and the Future

During the January meeting, there was a rather heated discussion about the upcoming NPRM (Notice for Proposed Rule Making) that the FAA will be issuing in June 2011. There has been a lot of speculation about the contents of this document and what impact that it will have on our hobby. As a result of the high degree of concern about this proposed rule, the FAA was present at the AMA Expo for a Q&A session on January 8th.

Reports of the content covered indicated that the heavy-handed reaction predicted (partly due to a "bad" AMA/FAA meeting in October) was not going to come to pass. A review of the information covered was posted at: <http://www.rcgroups.com/forums/showthread.php?t=1367963> (Post #11).

A quote from poster (Silent-AV8R) states:

"They were very clear that the FAA is not interested in harming model aviation. They also clearly stated that the ONLY motivation for this was the explosive growth in the UAV world and the increasing number of commercial UAV folks trying to operate and calling themselves models. Since the FAA had no rules to regulate those uses, they decided to write these rules."

It is likely that there will be SOME changes coming out of the NPRM, but since the FAA is prohibited by law to divulge the contents prior to release, all we can do in the meantime is wait. During this time, I am personally not planning a liquidation spree - I have already bought the first of several new models for the year.
